



## **Invitation to Bid**

### **Development of Portion of Demo Farm for Livestock and Poultry Programs**

#### **Demo Farm, Barangay Balansay, Mamburao, Occidental Mindoro**

1. **Municipal Government of Mamburao**, through the **Municipal Development Fund**, intends to apply the sum of **One Million Pesos (PhP 1,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract **Development of Portion of Demo Farm for Livestock and Poultry Programs – Demo Farm, Barangay Balansay, Mamburao, Occidental Mindoro – Contract ID No. 2023-Infrastructure-005**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. **Municipal Government of Mamburao** now invites bids for the above Procurement Project. Completion of the Works require **Fifty (50) Calendar Days**. Bidders should have completed a contract similar to the Project within the period **June 27, 2023 to June 26, 2023**. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **BAC Secretariat, 2<sup>nd</sup> Floor, Municipal Building, Mamburao, Occidental Mindoro** and inspect the Bidding Documents at the address given below from **8:00 AM - 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **June 7, 2023 to June 26, 2023** from the given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Pesos (PhP 1,000.00)**.
6. **Municipal Government of Mamburao** will hold a Pre-Bid Conference<sup>1</sup> on **June 14, 2023 – 9:00 AM** at the **Conference Room, 2<sup>nd</sup> Floor, Municipal Building, Mamburao, Occidental Mindoro**, which shall be opened to prospective bidders.
7. Bids must be duly received on or before **June 27, 2023 – 12:00 PM** by the BAC Secretariat through **manual submission** at the **BAC Secretariat, 2<sup>nd</sup> Floor, Municipal Building, Mamburao, Occidental Mindoro**. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **June 27, 2023 – 2:00 PM** at the **Municipal Conference Room, 2<sup>nd</sup> Floor, Municipal Building, Mamburao, Occidental Mindoro**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. **Municipal Government of Mamburao** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
